Education and Business Standards

Econologics Financial Advisors, LLC (“EFA”) requires that all advisors it employs have a Bachelor's degree and/or further coursework demonstrating knowledge of investments, financial planning and tax planning. Examples of acceptable coursework include: Bachelor's degree, MBA or RFC®. Additionally, advisors must have work experience that demonstrates their aptitude for investment management and financial planning.

EFA requires that any employee whose function involves determining or giving investment advice to clients must:

- Have previous experience in insurance, investments, accounting or financial planning;
- Be properly licensed for all advisory activities in which they are engaged.

Professional Certifications

Employees have earned certifications and credentials that are required to be explained in further detail.

Registered Financial Consultant (RFC®): Registered Financial Consultant® designation requires to meet examination, experience and ethics requirements and annual certification fees. In addition, to maintain the RFC® designation one is required to meet rigid standards and complete forty (40) hours of continuing education. This certification is issued by International Association of Registered Financial Consultants.

Uniform Registered Investment Advisor Representative (Series 65): The Series 65 is a securities license required by most U.S. states for individuals who act as investment advisors. The Series 65 exam, called the Uniform Investment Adviser Law Examination, covers laws, regulations, ethics, and topics such as retirement planning, portfolio management strategies, and fiduciary responsibilities. While there are no prerequisites in order to sit for the Series 65 exam, some firms require significant industry experience as well as other industry designations to manage client's accounts and provide professional investment advice.

Uniform Combined State (Series 66): The Series 66 is a combination exam that may be taken as an alternative to both the Series 63 and Series 65. The FINRA SIE and Series 7 exams are corequisites that must be successfully completed in addition to the Series 66 exam before a candidate can apply to register with a state as both a broker-dealer agent and investment adviser representative.
